## Maryland Value Added Producer Grants for Capital Equipment Now Available From MARBIDCO

Annapolis (August 7, 2020) ......The Maryland Agricultural and Resource-Based Industry Development Corporation (MARBIDCO) has announced a grant incentive funding opportunity to encourage Maryland's agricultural producers to expand or diversify their business operations by installing capital assets (equipment and fixtures) to make a product that is "value added." Eligible applicants must be a crop or livestock producer or processor, agricultural cooperative, seafood processor, or primary or secondary timber products processor, and have been in business for a minimum of two years. Hemp fiber grower-processors may be eligible to apply under certain conditions and must have been in business in Maryland on or before June 30, 2020.

MARBIDCO will offer incentive grants of between \$2,500 and \$10,000, distributed on a competitive basis, for capital projects that help farmers, forest product operations, and seafood processors to expand or diversify their business operations through value added activities. The financial match required from the rural business must be at least equal to the amount requested from MARBIDCO.

The application deadline is 4:00 p.m., on Thursday, September 24, 2020. (Applications received in the mail with a Saturday, September 16, 2020 postmark will also be accepted.) Grant award announcements should be made by mid-November 2020.
